Gift Aid

The Gift Aid scheme allows the Society to recover tax in respect of your subscriptions or donations at no cost to yourself as long as you pay income tax or capital gains tax at least equal to the tax the Society and any other charities or community amateur sports clubs you donate to reclaim (25p for each £1 which you pay). The donor is responsible for any shortfall. Council Tax and VAT do not count. If you have not signed a declaration before please consider doing so. Please notify the Society if you have signed previously and no longer pay sufficient tax or if your name or address changes. You can cancel the declaration at any time by notifying the Society.

Data Protection

The information you provide on the form is personal data which LNHS will handle in accordance with the General Data Protection Regulation. It will be used for sending you publications and otherwise in accordance with the legitimate interests of the LNHS and you as a member. If you have signed the Gift Aid declaration, we have a legal obligation to retain certain records in support of our Gift Aid claims. Full details of how we look after personal data and your rights in relation to this are included in the Privacy Notice published on our website. A paper copy can be obtained from Robin Blades.
